Public Worship

Preparations are underway for the re-opening of Churches for public services. This, according to the latest information, may take place from the 23rd of July. This is what you can expect.

All being well Mass resumes on Sunday 26th July – the 17th Sunday in Ordinary Time

1. Seating according to physical distancing rules. Currently, OLOL would have a capacity of 53 and St Martins, 47. Households may sit together. You will be guided to a seat by a passkeeper- you will most likely be unable to sit where you normally do.

2. You will need to wear a face covering. Exemptions are children under 5 and those with a condition such as asthma. We have a limited supply of masks if you do not have your own.

3. You will need to sanitise your hands on entering and leaving. This will be provided. Please avoid touching statues and other surfaces. If you wish to light votive candles, please bring your own lighters.

4. There will be no music or singing, ministers of communion, altar servers or sacristans. Only the priest will be allowed in the sacristy and toilet facilities will not be available.

5. Mass will be celebrated without the Gloria or Creed and only one reading and the gospel.

6. Holy Communion (under the form of bread only) will be distributed after the final blessing and people are asked to leave immediately.

7. There will be no Teas etc. after Mass.

9. The church will have to be cleaned after each service.

10. in order to accommodate as many people as we can these are the proposed mass times.

The First Minister, Nicola Sturgeon, announced in her statement on 9th July :

Public Worship

'After careful consideration, we have decided that from 15 July, places of worship can reopen for communal prayer, congregational services and contemplation. However, numbers will be strictly limited; 2 metres physical distancing will be required; and **there will be a requirement to collect the contact details and time of attendance of those entering a place of worship.** Unfortunately, given what we know of transmission risks, singing and chanting will also be restricted.

Funerals

In addition, and linked to that previous change, we will also ease restrictions on attendance at services and ceremonies for funerals, weddings and civil partnerships however, **numbers will be even more limited than for worship generally and physical distancing will be required.**

I must stress that this change applies only to services. Associated gatherings such as wakes or receptions must continue to follow the limits on household gatherings and hospitality'
